Article I - Name

The name of this club shall be Young Conservative Club & TPUSA Chapter

Article II - Purpose

The purpose of this club shall be providing opportunities for conservative students to have safe, civilized discussions on campus, and to promote the values of free market and limited government.

Article III - Eligibility

Every currently enrolled student in SPHS, except those who are removed due to the violation of Article VII section 1, is eligible to join the club.

Article IV - meetings

All meetings will be held on campus in the club advisor's room, on the Tuesday of every week, under the supervision of the club advisor.

Article V - Dues

The dues shall not exceed \$0.

Article VI - Positions and their duties

1. The President: schedule all meetings and events, determines the agenda of this club.
2. The Vice-President: Assist the President and assume his duties during absences. In charge of fundraising activities, and in charge of designing the detail of each individual club activity
3. The Treasure: In charge of all things concerning finance. Responsible for creating a budget., collecting/receipting club money, and for processing check requests/purchase orders.

4. Secretary: Send in any necessary bulletins, oversees and corrects all errors made by other officers. He/she shall also take minutes of the meeting.

Article VII - Speech

Section 1 - The members of this club will have freedom of speech, but limited to:

- Threatens and intimidations are never allowed.
- Disrespect towards any other club members, teachers or peers is never allowed.

Section 2 - The members who violate Section 1 will be expelled from this club, and will be reported to the school officials if necessary

Article VIII - Constitutional Amendments

A Constitutional amendment requires at least two thirds votes from all club members, and then must be approved by the SPHS Club Commission.
