**NARRATIVE**

## INCIDENT WAS REPORTED VIA TELEPHONE

I am Officer Arana/8544 with the Seattle Police Department. I am currently assigned Telephone Reporting Unit TRUN1. On 1/24/22 I spoke to the complainant via telephone about an assault type call. The call was originally broadcast as follows;

“REQ TO REPORT ASSLT THAT OCC'D ON 1/20, NO WPNS, AVAIL UNTIL 2300, CB POLICY ADV”

I spoke with the victim who was identified as H██████, S██████y A. She related to me that she had recently met PRICE, Daniel J in person. She said that he is well known and called him a public figure. I confirmed with her that she was speaking of PRICE from Gravity Payments, and she confirmed. She said that they occasionally would talk on Instagram about work. She said that she reached out to him in December and told him that he was doing good work and that she wanted to meet in person to speak with him about professional matters. H██████ said that she had no romantic intentions and that she currently has a boyfriend.

H██████ said that he agreed to meet with her on 1/20/22 at a restaurant called De Fiora in downtown Seattle. She said that he got very drunk and when they were about to leave, she told him that she wanted to get an Uber. She said that the app uninstalled in her phone so it was taking longer than usual for her to order one. PRICE suggested that they wait inside his blue Tesla since it was cold outside. H██████ agreed.

H██████ said that as soon as he got into the car, he immediately advanced on her, in an attempt to kiss her. She pushed him away and then he grabbed her throat. She said that she was very scared of him because he had a very angry look in his eyes. She said that at that point, his demeanor changed and he became incredibly angry. She said that he got angry about how long the Uber was taking, so he put the car in drive and drove off. H██████ said that she contacted her boyfriend and told him that he needed to pick her up immediately. He said that they would meet the Uber at the Northgate park and ride. She said at this point she was scared for her safety because he was very drunk and was driving, and he grabbed her throat.

She said that when they arrived at Northgate, he began doing donuts in the top parking lot. H██████ advised me again of how scared she was. She also added that she just tried to deescalate the situation by asking him questions because she did not want to make him angrier. She also said that she had a sprained ankle and was afraid to get out because she wouldn't be able to run away.

H██████ added that after he stopped doing donuts, he tried kissing her again and after she pushed him away the second time, he grabbed her throat again and was pulsing his hand for minutes. She said that she was able to breathe because he was pressing on the sides of her neck and wasn't obstructing her windpipe. She said that she was terrified that PRICE would do something further. She said that PRICE then got out of the vehicle and went into the back seat and laid down. She said that her boyfriend then picked her up and she told him the whole situation.

H██████ added that she told her father the next day about what happened. H██████ said that she did not have any bruising on her neck. She also added that the next day, PRICE texted her and said “Thanks for meeting me last night ” and she did not respond.

I provided H██████ with the incident number for her records.
