Allegation #1 - Accused PTA of Mishandling Funds - Tradition Was Not Followed


Finding - SUSTAINED

Reasoning - (Admission.)

Mr. Ramirez admits that the process changed and ultimately, he should have not opened or even been handling PTA monies. He checked with PTA Council who told him the same. See Mr. Ramirez interview. Questions 58-70.

> Finding NOT SUSTAINED




Allegation #3 - Called Mrs. Silvia Torres a derogatory name - (Fucking Bitch)

Allegation #5 - Unprofessional Behavior and Statements - October 4, 2019

Finding - PARTIALLY SUSTAINED

Reasoning - (Admissions / Conflicting Accounts and Preponderance Standards)

The following people were interviewed and asked to recount what occurred at the October 4, 2019 "Fall Festival" planning meeting:

(Refused to Participate - Erika Avelar)

The statements of Mrs. Sanchez and Mrs. Hernandez form the basis of Allegation #5. Some of the incidents that are alleged to have occurred in that meeting are admitted to by some participants and refuted by others. There is nevertheless, a preponderance, based on admissions and statements that at least some of the contentious conduct occurred.

Mrs. Sanchez and Mrs. Hernandez Allegations

- > Mr. Ramirez pointed his finger at Mrs. Hernandez and told her to step down.
- > Mr. Ramirez was verbally aggressive and physically agitated. (Eye rolling, raising
- Mr. Ramirez said he could slap or hit a child and not get fired.
- Mrs. Torres said Mrs. Hernandez should not have complained.
- > Mr. Ramirez made unacceptable statements such as, How's that working out for you, my resume is good, I'm principal of the year, I'm not going anywhere, District is tired of you, PTA council is tired of you.)
- Mr. Ramirez came into that meeting, "hot, for Lorena's head, let his rage out, thinks he's untouchable, promises one thing and does another and does not have the same behavior with everyone."

Statements supporting Allegation #5

- > Q18 Mr. Ramirez was "really mad" and told Mrs. Hernandez, "It sounds like he wants your head."
- Q24 There's nothing that can be done against him. He knows that.
- Q32 Mr. Ramirez raised his voice at Lorena.

• Statements refuting Allegation #5

- > Q15 and Q16 Hidrogo can't remember if Mr. Ramirez said anything about hitting a child.
- Q17 Mr. Ramirez did not specifically say the District is tired of you to Mrs. Hernandez.
- Q26 They were both heated at each other.
- > Q40 The problem lies with both of them.
- > Q75 It was heated and he was mad and upset but not to the point where he should be disciplined for anything that happened in that meeting.

• Statements supporting Allegation #5

- > Q15 Mr. Ramirez was firm in asking, "How's this working for you."
- Q17 Mr. Ramirez wasn't screaming but he was serious.
- Q18 Mr. Ramirez was serious and direct.
- Q29 Mr. Ramirez said, I'm principal of the year."
- Q39 Mr. Ramirez told Mrs. Hernandez that PTA Council was tired of her.
- > Q42 Mrs. Torres told Mrs. Hernandez that she did not have to reach out to the district to complain.

Statements refuting Allegation #5

- Q15 Mr. Ramirez did not raise his voice.
- > Q18 Mr. Ramirez didn't say anything inappropriate.
- > Q26 Reference requirements of electrical issues ... Mr. Ramirez wanted them to be safe. It was about logistics and fuses blowing.
- Q27 It was not implied that the meeting shouldn't be talked about outside.
- Q28 Mr. Ramirez did not say, "My resume looks good."
 Q31 Mr. Ramirez did not say, "I have insurance, so I'm covered."
- Q32 Mr. Ramirez did not say, "I could slap a kid and not get fired."

- Statements supporting Allegation #5
- None.
- Statements refuting Allegation #5
- > Q5 Mr. Ramirez did not change electrical requirements from the past.
- > Q9 Mr. Ramirez was not mad in the meeting.
- > Q13 Mr. Ramirez made no reference to slapping a child.
- > Q14 Mr. Ramirez did not say to Hernandez, "The district is tired of you."
- > Q15 Mr. Ramirez did not say to Hernandez, "PTA Council is tired of you."
- Q29 Mr. Ramirez has not been rude to anyone.
- Statements supporting Allegation #5
- > Q8 Mr. Ramirez raised his voice as did other people in the meeting.
- > Q9 Mr. Ramirez was irked and upset.
- > Q12 Mr. Ramirez took his time in signing the permit.
- Q15 Anything to do with PTA irked Mr. Ramirez. He probably did wait a little bit long in signing it.
- > Q17 Mr. Ramirez refers to Mrs. Hernandez as sneaky.
- > Q18 Mr. Ramirez sometimes "stonewalls" PTA.
- > Q19 Mr. Ramirez might "needle" PTA.
- > Q33 Mr. Ramirez said, "I'm principal of the year."
- > Q37 Mr. Ramirez said to Mrs. Hernandez, "The District is tired of you."
- > Q38 Mr. Ramirez said to Mrs. Hernandez, "PTA Council is tired of you."
- > Q41 Delgadillo told Mrs. Hernandez she did not need to reach out to District over disagreements with Mr. Ramirez.
- Statements refuting Allegation #5
- > Q21 Mr. Ramirez was calm and clear until everybody else raised their voice.
- Q28 Mr. Ramirez walked out of the meeting but only because he had another commitment scheduled.
- Q30 Nobody said anything about not talking about what happened in the meeting outside closed doors.
- > Q35 Delgadillo can't remember if Mr. Ramírez said anything about being able to slap a child.

Ramirez

- Statements supporting Allegation #5
- > Q69 Q93 Mr. Ramirez said, "I'm a big boy. I use big words,"
- > Q79 Reference saying he could hit a child; Mr. Ramirez does not know if he said it or not.
- Q80 Mr. Ramirez denies saying that he could hit a child unless Mrs. Torres, Mrs. Delgadillo or Mr. Pullen said that he did then he did say it. But if a PTA parent is the only ones who make the allegation then he didn't say it.
- > Q81 Mr. Ramirez denies saying he was principal of the year unless Mrs. Torres or Mrs. Delgadillo said he did then he would admit to it.
- > Q85 Mr. Ramirez admits to saying his resume was good.
- > Q88 Mr. Ramirez admits to saying he is not going anywhere.
- > Q89 Mr. Ramirez admits to saying, "How's that working out for you?"

- > Q89 Mr. Ramirez admits to telling Mrs. Hernandez the District is ignoring her because she complains so much.
- > Q90 Mr. Ramirez told Mrs. Hernandez she needs to step down.
- > Q92 Mr. Ramirez admits to saying something about having insurance.
- > Q93 Mr. Ramirez admits to saying that PTA Council member told him that Mrs. Hernandez causes the most trouble for him out of all the PTA presidents.
- > Q95 Mr. Ramirez admits to the meeting being "direct."
- > Q96 Mr. Ramirez said he told the PTA in the meeting, "how things are going to be."
- Statements refuting Allegation #5
- > Q86 Mr. Ramirez denies saying he was untouchable.
- > Q98 Mr. Ramirez denies pointing his finger at Mrs. Hernandez or standing over her in a threatening manner.

(Note - Because of these admissions by Mr. Ramirez, and several corroborating statements by Mrs. Delgadillo , there exists a preponderance of evidence that at least parts of this meeting were contentious. See Board Policy 4030. Paragraph 1. Also see preponderance justifications under Part 2 of this report.)

PART 2 - Allegations or Stonewalling / Roadblocking PTA - Allegation #9

Finding - PARTIAULY SUSTAINED

Reasoning - There are numerous corroborating allegations from the complainants. In addition there are supporting statements from PUSD staff on some of the allegations along with some vague admissions made by Mr. Ramirez.

There also exists several "Coincidental" events that just seem to happen when Lorena Hernandez was PTA President.

There is a preponderance of evidence that at least some level of non-cooperation and vitriol existed between Mr. Ramirez and Mrs. Hernandez / PTA. The finding of "Partially Sustained" was made because some of the things that were changed were probably correctly changed but the fact they were all discovered and changed under this PTA is what is suspicious preponderance. In addition, there are other witness statements that support that there were stonewalling type issues between Mr. Ramirez and PTA.

Ramirez

Statements / Admissions supporting Allegation #9

"Coincidental Events" - (Note - It should be noted that some of these "Coincidental Events" may have been changed for legitimate reasons. Again, the timing and volume is being pointed out as preponderance.)

Q40 - Annual Fund became a priority over PTA fundraising.

Q51 - Procedure in storing food for the "Fall Festival" changed.

Q58 - A change in the way PTA monies are handled.

 Q66-69 - Mr. Ramirez doesn't know how PTA monies came to be allowed stored in the SRE safe.

 Q90 - Mr. Ramirez chooses 2020 to not participate in a "Read-a-Thon" principal event.

Q132 - Mr. Ramirez took access to "Raz-Kids" away from PTA.

Q139 - The PTA calendar meetings become of no use.

 Q145 - 2020 was chosen as the first year in the past four to not have a 2nd Book Fair.

 Q151 - Mr. Ramirez said it has always been policy from Mrs. Shirley Barrett about having permits approved 60 days in advance but no one ever followed it in the past. (PTA under Mrs. Hernandez was made to follow it.)

Q207 - Mr. Ramirez states he is not going to do the parents of PTA students any favors emphasizing, "I'll go on record for that."

Other Relevant Statements From Mr. Ramirez - Forming Preponderance

> Q69 - Mr. Ramirez - "I'm a big boy. I use big words."

Q80 - Mr. Ramirez said he would admit that he said something about being able to hit a child and not get fired but only if one of his staff members said he did. Otherwise, he denies saying it.

> Q90 - Mr. Ramirez told Mrs. Hernandez to step down as president of PTA.

- > Q96 Mr. Ramirez said about PTA They don't like being told how things are going to be.
- > Q114 Despite being requested, Mr. Ramirez does not provide a date for a second "Book Fair."
- > Q118 Mr. Ramirez accuses Mrs. Schneiderman of being a "little bit off" if she is off of her medication.
- > Q129 Mr. Ramirez told people Mrs. Hernandez killed the Linda Vista project.
 - > Q131 Mr. Ramirez said that PTA members are called, The friends of the friendless."
 - Q133 and 138 Mr. Ramirez admits that his actions look like he is retaliating against PTA, calling it the "perfect storm." (Mr. Ramirez later says just the opposite in Q188.)

> Q139 - Mr. Ramirez said the PTA planning calendar and meetings that occurred in the past are of no use.

> Q146 - Mr. Ramirez admits that not having a second "Book Fair" could like retaliation.

Q148 and 151 - Mr. Ramirez said Mrs. Hernandez is never a consideration and he could care less how she feels about things. He adds that she needs to get a therapist.

> Q159 - When confronted that a staff member said they told Mr. Ramirez he shouldn't be holding up PTA requests Mr. Ramirez replied, "I don't think so."

> Q161 - When confronted that a staff member said he was "needling" PTA, Mr. Ramirez replied, "They don't know what I'm thinking."

> Q162 - Mr. Ramirez states his memo reference getting prior approval for all use of SRE property he said he did not mean PTA board meetings and that Mrs. Hernandez knew this.

Q167 - Mr. Ramirez displayed retaliatory behavior when asked about the "Roxy" event. Mr. Ramirez said he might be able to hold that in referring to possibly telling Roxy's family what the allegation was and how PTA was disrespecting them. Mr. Ramirez said he would tell them and then deal with the consequences.

Q175 - Mr. Ramirez said he did not participate in a fun principal "Read-a-Thon" event because of the relationship with PTA and that he did not want to be the "monkey on display."

> Q178 - Mr. Ramirez admits to not attending as many PTA board meetings but only because he was not invited.

Q181. - Mr. Ramirez cites as an example of not responding to PTA emails because they go to his staff and not to him. (Note - Serious weight must be given to statements that made that support allegations against Mr. Ramirez. is part of Mr. Ramirez's staff. has nothing to gain by being honest and conversely risks possible damage to her relationship with her supervisor, Mr. Ramirez. Also, she does contradict herself in places, also leading to the stated Finding.)

Statements supporting Allegation #9.

Q12 - Mrs. Hernandez submitted the request permit for "Fall Festival" in August
 2019.

> Q13 - Delgadillo took the request to Mr. Ramirez on the same day.

- Q15 There was bad history and tension between Mr. Ramirez and PTA. Anything to do with PTA irked him. (Mr. Ramirez) probably did wait a little bit long on signing it
- Q17 Mr. Ramirez refers to Mrs. Hernandez as sneaky.
- Q18 Mr. Ramirez stonewalls PTA sometimes.
- > Q19 Mr. Ramirez needles PTA.
- > Q23 Mr. Ramirez signed the permit several weeks after it was submitted.

> Q63 - Mr. Ramirez held the "Fall Festival" permit.

> Q64 - Mr. Ramirez holds the permit requests unnecessarily long.

> Q68 - Mrs. Delgadillo told Mr. Ramirez that holding the requests too long might not look good.

> Q71 - Mr. Ramirez held up the "Fall Festival" permit request.

Q85 - Mrs. Delgadillo believes Mrs. Hernandez has valid grievances but also culpability.

> Q90 - Mr. Ramirez did not participate in "Read-a-Thon" because of the relationship

with Mrs. Hernandez.

- Q93 Mr. Ramirez has given staff a "head up" about Mrs. Hernandez saying she likes to prey on newbies.
- > Q95 Mr. Ramirez was offended that he wasn't asked to MC talent night.
- > Q100 Mr. Ramirez does not go to the PTA board meetings.

Q105 - Mr. Ramirez held up the "Fall Festival" permit.

- > Q106 Sometimes his is stonewalling PTA and sometimes he is not.
- > Q109 Mr. Ramirez does not promote PTA as much as he did in the past.
- > Q111 Mr. Ramirez doesn't like Mrs. Hernandez and she doesn't like him.
- Q113 As a parent, Mrs. Delgadillo thinks that Mr. Ramirez is stonewalling.




Q56 - There are always rooms available. We can assign PTA a room 5 minutes before the meeting.

> Q61 - Mr. Ramirez is not holding permit requests.


- > Q62 It goes both ways. Mrs. Hernandez has put out fliers without prior approval.
- > Q70 Mrs. Delgadillo said had not specifically spoke to Mr. Ramirez on the issue of holding up permits.
- > Q85 Mrs. Delgadillo believes Mrs. Hernandez has valid grievances but also culpability.

> Q88 - Mr. Ramirez is not stonewalling this particular PTA with more or unreasonable requests.

58. Q - Please address the change in rules from allowing PTA to take money home to requiring it to be put in the safe? Page #10 of Mrs. Sanchez' report says that is what you requested ... (Did you report this to your boss as you said you were going to do.) (Why did you retrieve the money at the first of the week until waiting until the end of the week?) Do you have the combination? RR - This was a PUSD district wide process change. PUSD installed safes in every school and had them mounted on a wall or anchored into the floor. This also came about in Lorena's first year as PTA president. In the past PTA had a counting sheet. At the end of the each of the event they would have a count of the ones, fives, 10, etc. In the past at the end of the day PTA with any event, a few of us would break away with 3 people or more we would count the money and double check it and someone would take it home.

59. Q - Was it sealed and initialed in the past? RR - Not that I'm aware of.

- 60. Q So what went sideways this time?

 RR I felt it was responsibility to know how much money was in the safe for the liability of it.
- 61. Q How did you know even know there was PTA money in the office safe? RR I don't know how I knew. I think I opened it. I have the combination and so does Jennifer Delgadillo.
- 62. Q So you come into work ... how did you know to open the safe?
 RR Sometimes confiscated items are put in the safe. We keep petty cash in there if we need something, who knows (how I knew.)
- 63. Q So you open it and find this taped up envelope?

 RR Yes. I videoed it and opened it and counted it with the office staff.
- 64. Q You said you later learned from PTA council that you weren't responsible for PTA money?

 RR Correct ... and that I had no accountability for it and they never put money in the safe again.
- 65. Q So, in reality you didn't need to open their envelope and count the money? RR Correct but also it should have never been in there ... knowing what I know now.
- 66. Q How did it come to be allowed there in the first place then?

 RR I don't know. That's a good question. I believe there was a time when I saw PTA counting money for a t-shirt event and I offered for them to put it in the safe if they wanted to and it upset them. I think I told Lorena she could put the money in the safe and she should count it first. She said they didn't have the time and resources for that.
- 67. Q Did you later call Sebastian and Lorena about this?
 RR Not Sebastian, maybe Lorena. It didn't go well. She was upset that it wasn't my right to open it. It was my responsibility to open it but I was set straight by PTA council. Technically knowing what I know now it shouldn't have been there in the first place and I should not have opened it.
- 68. Q Was that conversation heated?

 RR I've been dealing with her for 6 years. She's not going to change.
- 69. Q She says you yelled at her?
 RR I'm a big boy. I use big words. I've never been accused of being mild mannered.
- 70. Q Could she have interpreted you as yelling at her? RR I don't know what she interpreted.
